

# Flood Relief Rebate for Businesses



Businesses whose heating, cooling, refrigeration, or commercial kitchen equipment was damaged by recent floods can receive a flood relief rebate of 100% of costs up to \$4,000 per product for up to four products, in addition to standard offers, for the purchase of new qualifying equipment.

## Steps to Getting Your Rebate

- Confirm eligibility (see last page)
- Purchase qualifying product(s)
- Complete and sign the form
- Submit form with sales receipt or invoice, W9 (if applicable), and product rebate form (if applicable)

## Eligibility & Exclusions

Offer is effective 9/1/23. Offer is limited to four flood relief rebates per customer, in the amount of 100% of eligible equipment costs up to \$4,000 for each qualifying product purchased.

An eligible customer is a business in the state of Vermont that sustained physical damage to its heating, cooling, refrigeration, or commercial kitchen equipment due to flooding on or after July 7, 2023.

Qualifying equipment includes the following products. Confirm eligibility at [efficiencyvermont.com/bizflood](https://efficiencyvermont.com/bizflood). Product must be listed on Efficiency Vermont's qualifying products list at the time of purchase. Equipment must be purchased on or after 7/7/2023 to qualify for rebate. Used, rebuilt, or refurbished equipment is not eligible.

#### Heating & Cooling

- Ducted or ductless heat pump
- Furnaces (Oil, Liquid Propane)
- Boilers (Oil, Liquid Propane)

#### Water Heating

- Heat pump water heater

#### Refrigeration

- High efficiency evaporator
- High efficiency condensing unit
- Commercial refrigerator or freezer

#### Commercial Kitchen Equipment

- Commercial ice maker
- Commercial dishwasher (under-counter, stationary single door, single tank conveyor, multi tank conveyor, pot pan utensil)
- Commercial oven (convention, combination, conveyor, rack)
- Steam cooker
- Fryer
- Griddle
- Hot food holding cabinet

Product and flood relief rebates will not exceed the purchase price, and excludes all other costs including shipping, sales tax, or disposal/recycling expenses. Customer is responsible for any tax liability associated with rebate payment. Allow 60 calendar days for delivery of payment. Incomplete or missing information will delay processing.

A complete rebate application must be received by Efficiency Vermont in order to receive the flood relief rebate.

Rebate is subject to change without notice. Rebates are available on the first come, first served basis and will expire when funds are exhausted.

IBM, Global Foundries, Omya, Energy Savings Account Pilot participants, and Vermont electric utility companies are not eligible.

VGS customers installing qualifying furnaces or boilers are not eligible for this rebate, but may be eligible for support through VGS commercial energy services programs. If determined to be the case, Efficiency Vermont will share your application with VGS and they will coordinate next steps with you.
