

Considering your first reverse osmosis system?

Rebates sweeten the deal.



Your sugar house can see quick returns from the installation of a Reverse Osmosis (RO) system.

By removing water content prior to boiling, an RO can:

- > cut boiling time by 50-75%
- > reduce wood or fuel consumption and costs

ROs keep time and costs under control, so you can keep up with production without sacrificing all the fun.

1. Determine eligibility:

- Must be a first-time RO purchase, for an existing sugaring operation. Leasing, renting, or borrowing an RO during prior seasons will disqualify the applicant.
- Available to qualifying producers who produced more than 80 gallons per year.
- Evaporators must use fuel oil, cord wood, propane, or kerosene.
- All system equipment must be new, commercially-available (not homemade) for maple applications, and installed per manufacturer's recommendations.
- RO system may be professionally or self-installed.

2. Get pre-qualified:

- Obtain a quote for a new maple RO system from a vendor.
- Complete this pre-qualification form.

Rebates:

- Rebates are available for systems with 50-1200 gallon per hour (GPH) ratings. For systems over 1200, please call 888-921-5990.
- To find current rebate amounts, visit www.efficiencyvermont.com/rebates
- Upon approval, your rebate will be reserved, and paid to you within 60 days after we receive a copy of your paid invoice and a signed rebate agreement.

Financing:

Efficiency Vermont partners with Vermont State Employees Credit Union to provide loans to Vermont agricultural producers for qualifying energy efficiency improvements.

To apply, please contact Efficiency Vermont **before** starting your project. Loans cannot be provided if equipment has already been purchased.

Additional Maple Opportunities:

Efficiency Vermont also has custom rebates available for steam-enhanced pre-heaters, VFDs for sap vacuum pumps, and energy efficient LEDs.

Pre-approvals are required and rebates will be awarded on a first-come, first-served basis.

Inspection & metering: Efficiency Vermont retains the right to inspect any equipment installation prior to issuing a rebate, and may install metering equipment on approved RO systems for the following sugaring season.

Rebates may be considered taxable income: Depending on tax filing status, rebate recipients may receive a 1099 after receiving a check.

Pre-Qualification Form

The information you provide below will help verify that the maple RO equipment is eligible and cost-effective, in order to pre-approve the project and reserve a rebate.

- Efficiency Vermont staff will contact you with pre-approval notification within 10 business days.
- Incomplete or missing information will delay processing and pre-approvals.
- If your project is approved you will be sent a rebate agreement for your signature.
