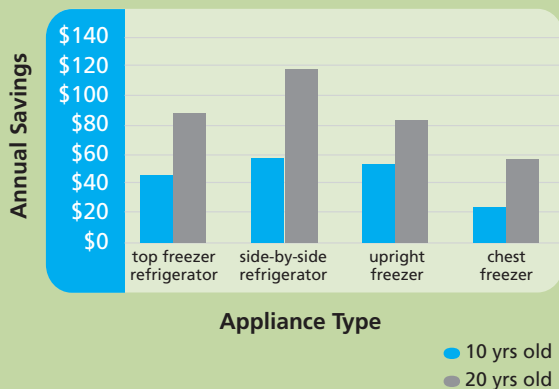

If your refrigerator or freezer was manufactured more than 10 years ago, it could use as much energy as two new ENERGY STAR qualified models. ENERGY STAR qualified refrigerators can save over \$100 per year, and ENERGY STAR qualified freezers can save over \$80 per year, depending on the model being replaced.
