Limit of one rebate per Vermont residential electric utility account per calendar year. All products must be new and installed in Vermont. Used, rebuilt, or refurbished products are not eligible. Efficiency Vermont reserves the right to conduct field inspections to verify installations.

Rebate must be submitted on or after the program/offer "effective date" and within 365 days of the product purchase date. In the event a rebate is discontinued or changed, submissions will be honored at the higher amount if the qualifying product was purchased prior to the effective date of the change, with installations and rebate submission occurring within 30 calendar days of that date.

Rebate payment excludes shipping, sales tax, and disposal/recycling expenses. Customer is responsible for any tax liability associated with rebate payment. Allow up to 60 calendar days for delivery of rebate. Incomplete or missing information will delay processing and payment.
